[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus located in Quarter Township 1, Township 1, Range 19 (USML) and being a part of a 0.322 acre tract of land conveyed to Walter G. Reiner and Lois J. Reiner by deed of record in I.N. 200102010021084 of the Recorders office, Franklin County, Ohio and being more particularly described as follows:

Commencing at the centerline monument set at the intersection of Old Henderson Road and Kenny Road, said point being the northwest corner of a right-of-way parcel conveyed to the City of Columbus in DB 3443 at page 410 (Parcel 28-WD Judgment Entry FCCCP Case No. 73CV-08-2077), said point also being at station 67+04.48;

Thence S 2°52'45" W along the centerline of Kenny Road the west line of said parcel 28-WD a distance of 24.49 feet to a point, said point being located at station 66+79.99;

Thence S 87°07'15" E a distance of 40.00 feet to an iron pin set in the easterly right-of way line of Kenny Road at the intersection with the southerly right-of way line of Old Henderson Road and being the grantor's northwest corner, and also being a point in the east line of west line of said parcel 28-WD, said iron pin being 40.00 feet right of station 66+79.99, said iron pin being also the **TRUE POINT OF BEGINNING**;

Thence S 87°51'07" E along the grantor's north line and said southerly right-of way line of Old Henderson Road and the south line of a tract as conveyed to the Fair-Lancaster Company, Inc. in DB 1928 at page 613 a distance of 9.28 feet to an iron pin set, said point iron pin being 49.28 feet right of station 66+80.11;

Thence crossing said grantor's 0.322 acre tract S 49°03'40" W a distance of 12.86 feet an iron pin set in the grantor's west line and said easterly right-of way line of Kenny Road, said point iron pin being 40.00 feet right of station 66+71.20;

Thence N 02°52'45" E along the grantor's west line and said easterly right-of way line of Kenny Road a distance of 8.79 feet to the **TRUE POINT OF BEGINNING**.

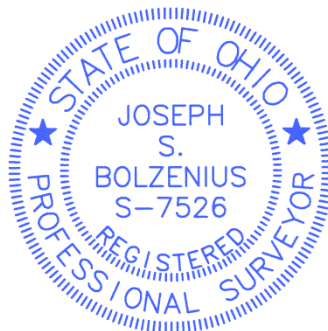
The above described area is contained with the Franklin County Auditor's Parcel Number 010-129865, with a present road of 0.000 acres occupied. Within said boundary is 0.001 acres, more or less.

This description and survey was prepared and reviewed on March 4, 2015, by Joseph S. Bolzenius.

All iron pins set are 5/8" rebar (30" long) with a yellow plastic cap stamped "R/W PATRICK INC" and are to be placed at the completion of construction by the City of Columbus Survey Department.

The centerline and stationing described in this document refers to the centerline of construction on file with the City of Columbus plan "Kenny Road Sidewalk Improvements (3113 Dr. E)".

The basis of bearings in this description area based on the State Plane Coordinate System, Ohio South Zone, NAD83 (NSRS 2011), which were determined by GPS observations conducted by the Patrick Engineering survey staff. The Columbus, Mount Vernon and McConnelville CORS stations were used, which establishes a bearing along the centerline of Kenny Road to be N 2°52'45" E between station 62+74.74 (just north of Folkestone Road) and Old Henderson Road.
