This project is scheduled to be advertised for construction in December 2010 and is currently being reviewed by the Ohio Dept. of Natural Resources for approval of a construction permit. The Peer Review must be completed as soon as possible in order to incorporate any potential revisions to the contract documents prior to advertising for construction. DPU intends to enter into a contract immediately upon approval of this legislation with tasks to be completed within 30 days of Notice to Proceed.

The current Peer Review scope of work is to be completed for \$49,392.31.
