Following the Legislation and execution of the construction contract, the work is slated to be completed within 80 days. Estimated construction would begin in February 2015, and completed by May 2015

Contract work is required to be completed in a manner acceptable to the City within 180 days from the date that a Notice To Proceed (NTP) is given by the City.

The addition of lighting in the Jefferson Park area would provide both a sense of safety and security to the residents. This may also deter criminal activity, which would lessen the financial impact on city resources such as Police and Fire Departments. The use of LED lighting will lessen the amount of pollutants.
