BEGIN FOR REFERENCE at a concrete monument with an aluminum cap labeled "Frank 144" located along I-70 and the entrance ramp for James Road;

Thence South 36° 52' 15" East a distance of 6698.92 feet to a 1" Rebar set at the centerline right-of-way intersection of Refugee Road (Station 63+08.57) and Courtright Road (Station 00+00.00);

Thence North 04° 16' 25" East a distance of 193.75 feet along centerline of Courtright Road (80 feet in width) to a point at centerline Station 01+93.75;

Thence North 85° 43' 35" West a distance of 40.00 feet crossing Courtright Road to a point on the westerly right-of-way line of Courtright Road and the easterly line of the Grantor's 0.712 acre tract, 40.00 feet left of centerline station 01+93.75 and being the **TRUE POINT OF BEGINNING** for the Temporary Easement herein described;

Thence leaving the westerly right-of-way line of Courtright Road on the following three (3) courses across the Grantor's 0.712 acre tract;

- 1. North 85° 43' 35" West a distance of 4.00 feet to a point 44.00 feet left of centerline station 01+93.75;
- 2. North 04° 16' 25" East a distance of 47.96 feet to a point 44.00 feet left of centerline station 02+41.70;
- 3. South 85° 43' 35" East a distance of 4.00 feet to a point on the westerly right-of-way line of Courtright Road 40.00 feet left of centerline station 02+41.70;

Thence South 04° 16' 25" West a distance of 47.96 feet along the westerly right-of-way line of Courtright Road to the **TRUE POINT OF BEGINNING**, containing 0.004 acres, more or less, being subject to all easements, restrictions, and right-of-way of record.
