To whom it may concern,

I contacted Sgt. Dale Resor in response to the request made by the Guernsey County Sheriff's Department regarding the vehicle equipment. The scope of the request involves the acquisition of the following:

- 30 Panasonic Toughbooks (computer laptops)
- 30 Toughbook Mounts
- 20 Blue & Red Light bars

The Division of Police previously used this equipment in its cruisers circa 2008. These Panasonic Toughbooks have reached their end-of-life and have since been replaced with new Fujitsu laptops. The Fujitsu deployment marks the third generation of replacements for the Division of Police since the Panasonic Toughbooks. The aforementioned light bars do not fit the current CPD cruiser platform since the police fleet has been upgraded. I was informed from Fleet Management there was no need or plan for future deployment of these light bars.

The Division of Police continues to store the Toughbooks, mounts, and light bars inside its facilities pending further direction. These Toughbooks currently fail to meet the minimum specifications for use within the Columbus Division of Police and would offer zero to minimal value to any other City of Columbus agency given the current technology platform already in use throughout the city. The Division of Police and the Department of Technology have no plans to reallocate the Toughbooks or their mounts for any future City of Columbus technology initiative.

After speaking with Sgt Resor regarding the Guernsey County Sheriff's current technology situation, providing them with this equipment would greatly improve their agency's operations as well as increase officer safety, productivity, and communication. This equipment will give their officers access to basic law enforcement tools resulting in more effective patrols on the throughways connecting their community with ours.
