The City of Columbus version of OnBase is currently on version 15. This proposal is to upgrade the current OnBase 15 to OnBase 16. Due to the nature of the current system installation, both City of Columbus DOT and PRIME3SG will have assigned tasks to ensure a successful upgrade.

Upgrade Phase 1

1. Current Status
 - a. OnBase 16 Test environment installed on DEV2
 - b. All components and solutions of the OnBase 15 PROD have been updated in this test system as at the time of upgrade
 - c. BZS is completing testing of OnBase 16
 - d. Department of Public Health (Vital Statistics) have not started testing.
 - e. Public Service solution is not available in DEV2 and they don't have a custom solution at this time.
 - i. No testing required in OnBase 16
2. Department testing – PRIME3SG and **DOT Task**
 - a. Configure click once installation – PRIME3SG Task
 - b. Install unity client for each test person – **DOT Task**
 - c. User Testing – **DOT Task**
 - d. Confirmation from DOT that Applications have been tested and production can be upgraded. – **DOT Task**

Upgrade Phase 2

1. Setup new processing servers for OnBase 16 – **DOT Task**
 - a. Workflow
 - b. Web/Application

- c. DIP/Sweep
 - d. OCR
 - e. Barcode
 - f. Admin
2. Install and configure OnBase 16 components – **PRIME3SG Task**
 3. Bring OnBase 15 PROD down – **PRIME3SG Task**
 4. Backup OnBase PROD Database and Diskgroups – **DOT Task**
 5. Install OnBase 16 Unity Clients (Uninstall OnBase 15 Unity Clients) to User PCs – **DOT Task**
 6. Upgrade OnBase 15 PROD database schema to OnBase 16 – **PRIME3SG Task**
 7. Repoint DNS entry (obproduction.columbus.local) to new server – **DOT Task**
 8. Bring OnBase16 Live – **PRIME3SG Task**
 9. Decommission Old OnBase 15 processing servers – **DOT Task**

Staging Environment

Staging “As Is”

- a. Uninstall OnBase 15 components in current STAGING server - **PRIME3SG Task**
- b. Install 16 components in current STAGING - **PRIME3SG Task**
- c. Upgrade STAGING DB to OnBase 16 - **PRIME3SG Task**
- d. Upgrade OnBase Accela API (Adapter) in STAGING – **PRIME3SG Task**

Assumptions

1. City of Columbus DOT will provide their full participation and endorsement of the project in order for it to proceed smoothly and successfully.
2. Target delivery dates will be based on City of Columbus DOT’s timely input and participation.
3. City of Columbus DOT must be fully engaged in project and assign resources to be available as needed.
4. City of Columbus DOT will install the all required Windows server roles, .NET Framework (PRIME3SG will provide the details) and Windows updates
