The following information has been provided concerning the City of Columbus' 2014 – 2015 annual objection to the renewal of liquor permits. After reviewing the State of Ohio, Franklin County, and City of Columbus' records regarding the above listed liquor permit establishment, the following information has been compiled with regard to a potential objection to the renewal of the permit issued by the State of Ohio.

The above listed liquor establishment has been issued a liquor permit from the State of Ohio, Division of Liquor Control, Permit # 4217850. The permit holder received a C1 & C2 permit. These permits grant the permit holder the privilege to sell beer and/or intoxicating liquor for off premises consumption as described by Ohio Law.

An "Inquiry of Violations" was received from the State of Ohio, Division of Liquor Control. The inquiry revealed that the permit holder has received the following administrative violations within the past 12 months

The Permit Holder has been charged with three violations, Improper Conduct – Receiving and/or Concealing Stolen Property, Improper Conduct – Not Covered Above, and Improper Conduct – Illegal Use of W.I.C. This case has not been assigned a case number by the Liquor Control Commission.

The Permit Holder has been charged with the violation of Improper Conduct – Illegal Use of E.B.T. This case has not been assigned a case number by the Liquor Control Commission.

The Permit Holder has been charged with the violation of, Improper Repacking and/or Splitting Beer. This case has been assigned case # 983-10 by the Liquor Control Commission. This case was heard by the Ohio Liquor Control Commission on 08/10/2010, at which time the Commission sustained the violation. The commission ordered a 2 day suspension or the permit holder pay \$400. The permit Holder paid the fine on 09/15/2010.

The Permit Holder has been charged with the violation of, Sale and/or Furnishing to a Person Under 21. This case has been assigned case #1759-09 by the Liquor Control Commission. This case was heard by the Ohio Liquor Control Commission on 12/11/2009, at which time the Commission sustained the violation. The commission ordered a 6 day suspension or the permit holder pay \$\$750. The permit Holder paid the fine on 01/12/2010..


