**DESCRIPTION OF A 0.001 ACRE**  
**TEMPORARY CONSTRUCTION EASEMENT**

Situated in the State of Ohio, County of Franklin, City of Columbus, lying in Section 22, Township 5 North, Range 22 West of the Refugee Lands, and being part of Lot Number Eleven (11) of Stegner and Ehring's Subdivision as recorded in Plat Book 10, Page 230 (Franklin County Auditor's Parcel Number 010-057814), as conveyed to Miletti Property Inspection, LLC by deed of record in Instrument No. 202002070018914 (all documents referenced herein are from the Franklin County Recorder's Office), and more particularly described as follows:

All station and offsets referenced in this description are from the right of way centerline of Kossuth Street.

Commencing, for reference, at the intersection of the easterly right of way line of Carpenter Street and the southerly right of way line of Kossuth Street, also being the Grantor's northwesterly corner and being 25.00 feet right of centerline station 66+94.93;

Thence South  $86^{\circ} 13' 35''$  East a distance of 33.42 feet, along the southerly right of way line of Kossuth Street and the Grantor's northerly line to a point 25.00 feet right of centerline station 67+28.37, and being the TRUE POINT OF BEGINNING of the Temporary Construction Easement herein described;

Thence South  $86^{\circ} 13' 35''$  East a distance of 15.00 feet continuing along the southerly right of way line of Kossuth Street and the Grantor's northerly line to a point 25.00 feet right of centerline station 67+43.37;

Thence leaving the southerly right of way line of Kossuth Street and the Grantor's northerly line across the Grantor's tract on the following three courses:

1. South  $03^{\circ} 46' 25''$  West a distance of 2.50 feet to a point 27.50 feet right of centerline of station 67+43.37;
2. North  $86^{\circ} 13' 35''$  West a distance of 15.00 feet to a point 27.50 feet right of centerline station 67+28.37;
3. North  $03^{\circ} 46' 25''$  East a distance of 2.50 feet to a point on the southerly right of way line of Kossuth Street and being the TRUE POINT OF BEGINNING containing 0.001 acres, more or less, subject to all easements, restrictions and rights of way record.

Prior instruments recorded as of this writing recorded as Instrument No. 202002070018914 in the records of Franklin County.
