Note:

Columbus Asphalt Paving, Inc. did not sign the proposal "...in their own handwriting" as directed in the bid submittal documents and Section 102.06 of the CMS: "The bidder's proposal must be signed in ink...." Instead, the signature area was stamped with their corporate stamp which includes the name and address of the company. After discussion with the City Attorney's Office, their opinion is: "The bid with the stamp is responsive because it responds to the bid specifications in all material aspects and it contains no irregularities or deviations which would affect the amount of the bid or give the bidder a competitive advantage. The stamp and the other signatures taken together [proposal bond, signature affidavit, non-collusion affidavit] clearly indicate that the bidder intends to be bound by the proposal."

Emergency Action:

Emergency action is necessary to allow for timely execution of this contract and construction to protect the safety and welfare of the public.
