Thence South 04 degrees 02 minutes 28 seconds West, along the existing centerline of right-of-way for James Road, along the west line of said ½ Section 29 and along the west line of said Caldwell Main Street Addition, a distance of 827.48 feet to a point, said point being 7.41 feet left of James Road proposed centerline of construction Station 131+11.85;

Thence South 87 degrees 52 minutes 52 seconds East, along the north line of said Lot 23 and along the south line of said Lot 22, a distance of 16.83 feet to an iron pin set, said iron pin set being 39.41 feet right of James Road proposed centerline of construction Station 131+12.66;

Thence South 04 degrees 03 minutes 12 seconds West, across said Lot 23, a distance of 31.69 feet to an iron pin set at a point of curvature, said iron pin set being 39.35 feet right of James Road proposed centerline of construction Station 130+80.34;

Thence along the arc of a curve to the left, continuing across said Lot 23, said curve having a radius of 24.00 feet, a central angle of 89 degrees 50 minutes 00 seconds, and an arc length of 37.63 feet to an iron pin set on the existing north right-of-way line for Mound Street, as established by said Caldwell Main Street Addition, being the south line of said Lot 23, said iron pin set being 63.01 feet right of James Road proposed centerline of construction Station 130+56.07, said curve being subtended by a long chord having a bearing of South 40 degrees 51 minutes 48 seconds East and a length of 33.89 feet;
