The work as part of this contract will consist of all labor and materials necessary for the construction of approximately 23,000 lineal feet of new 10 foot diameter sewer tunnel, shafts/drop structures, and all other appurtenances. This sewer will provide gravity sanitary sewer service to the rapidly expanding New Albany area.

Begin date = April 2016
 End date = December 2019
