Thence North 04 degrees 27 minutes 26 seconds East, along the existing north centerline of right-of-way for James Road and along the west line of said ½ Section 30, a distance of 510.12 feet to an angle point, said point being 9.00 feet left of James Road proposed centerline of construction Station 109+09.33;

Thence North 04 degrees 26 minutes 27 seconds East, continuing along the existing centerline of right-of-way for James Road and continuing along the west line of said ½ Section 30, a distance of 119.75 feet to a point, said point being 8.99 feet left of James Road proposed centerline of construction Station 110+29.08;

Thence **North 85 degrees 33 minutes 33 seconds West**, along a line perpendicular to the previous course, a distance of **35.00 feet** to the intersection of the existing west right-of-way line for said James Road and the existing south right-of-way line for Brownlee Avenue, both established by said East Minster Addition, being the northeast corner of said Lot 352, said point being 43.99 feet left of James Road proposed centerline of construction Station 110+29.08, said point being the **TRUE POINT OF BEGINNING** for the herein described right-of-way parcel;

Thence **South 04 degrees 26 minutes 27 seconds West**, along the existing west right-of-way line for said James Road and along the east line of said Lot 352, a distance of **6.49 feet** to an iron pin set, said iron pin set being 43.99 feet left of James Road proposed centerline of construction Station 110+22.59;

Thence North 59 degrees 50 minutes 34 seconds West, across said Lot 352, a distance of 14.96 feet to an iron pin set on the existing south right-of-way line for said Brownlee Avenue, being the north line of said Lot 352, said iron pin set being 57.46 feet left of James Road proposed centerline of construction Station 110+29.08;

Thence South 85 degrees 33 minutes 34 seconds East, along the existing south right-of-way line for said Brownlee Avenue and along the north line of said Lot 352, a distance of 13.47 feet to the POINT OF BEGINNING for the herein described right-of-way parcel.

The above described right-of-way parcel contains a total area of **0.001 acres** located within Franklin County Auditor's parcel number 010-090575.
