This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the Arterial Street Rehabilitation – Alum Creek Drive Phase B SR104-Williams Road project.

#### **Project Scope:**

This Project consists of the widening and reconstruction of 2.07 miles of Alum Creek Drive from Williams Road northward to Performance Way/Refugee Road South. The project will include the addition of curb and gutter, sidewalks, a closed drainage system, lighting, waterline as well as 2275 feet of widening and reconstruction on Williams Road and 850 feet of widening and reconstruction on Watkins road.

Fiscal Impact: Source of funds is 2011 DPS Bond Funds, DPU Bond Funds, OPWC Funds and ODOT Funds.

Engineer's estimate (revised), including 10% inspection: \$18,670,156.40

Low bid amount, including 10% inspection: \$18,788,841.89

#### Recommendation:

With reference to bids received on April 26, 2012, I wish to make the following recommendation for the subject improvement:

Contingent award is made to the lowest responsive, responsible and best bidder, George J. Igel Co., for their bid of \$17,080,765.35, which is \$107,985.90 over the engineer's estimate (revised) of \$16,972,869.45.

Contingent award is recommended at this time as the proposed sub-contractors for the George J. Igel Co. do not satisfy the DBE goal of 8% established for this project. In consultation with Jeff Peyton at ODOT, Mr. Peyton stated that the lowest, responsive, and responsible bidder will need to submit documentation to the City of Columbus demonstrating how they will meet the DBE goal after the intent to award is announced. All DBE contracts and ODOT C-92 forms must be returned to the City of Columbus within one (1) week of the contractor being notified of the intent to award the contract.

The contractor can also request that the DBE goal be waived. The waiver request must be submitted and reviewed by the City of Columbus before being submitted to ODOT. ODOT must then review and approve the waiver request before the contract between the City of Columbus and the contractor can be executed. There is no time limit for ODOT's approval process for the waiver request and there will be no extension of time for the project if the contractor wishes to pursue the waiver process.

Upon approval of ODOT that the DBE goal has been met or a waiver is approved by the City and ODOT, you will be notified and formal award be recommended. If the DBE goal cannot be met and the City and/or ODOT does not approve the waiver, the second lowest bidder will be contingently recommended and the same process followed.

This process may delay the estimated Council date.

Please respond to this e-mail indicating contingent approval of the recommended contractor – George J. Igel Co. – or approval of another contractor. If you approve another contractor please provide an explanation.
