[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Township 3, Township 2, Range 16 of the United States Military Lands and being 0.036 acres within a 1.048 acre parcel conveyed to ROMO II INVESTMENT CO LLC an Ohio limited liability company, as described in Instrument Number 200606210121665 and being more particularly described as follows:

Being a parcel of land lying on the right side of the centerline of a survey made for project Hamilton Road, made by the Department of Transportation, and being located within the following described points in the boundary thereof:

Beginning on the easterly proposed right-of-way of Hamilton Road, said point being 60.00 feet right of centerline Station 109+92.69;

Thence along the said easterly existing right-of-way of Hamilton Road, North 3°19'21" East, a distance of 144.80 feet to the northwesterly corner of the said 1.048 acre tract and being 60.00 feet right of centerline Station 111+37.30;

Thence along the northerly line of the said 1.048 acre parcel, South 86°54'02" East a distance of 21.00 feet to a point being 81.00 feet right of centerline Station 111+37.30;

Thence across the said 1.048 acre parcel, South 3°07'54" West a distance of 20.57 feet to a point being 81.10 feet right of centerline Station 111+17.00;

Thence across the said 1.048 acre parcel, North 86°40'39" West a distance of 12.07 feet to a point being 69.00 feet right of centerline Station 111+17.00;

Thence across the said 1.048 acre parcel, South 3°19'21" West a distance of 112.00 feet to a point being 69.00 feet right of centerline Station 110+05.00;

Thence across the said 1.048 acre tract, South 86°40'39" East a distance of 3.00 feet to a point being 72.00 feet right of centerline Station 110+05.00;

Thence across the said 1.048 acre tract, South 3°19'21" West a distance of 12.26 feet to a point on the southerly line of the said 1.048 acre tract and being 72.00 feet right of centerline Station 109+92.74;

Thence along the said southerly line, North 86°54'39" West a distance of 12.00 feet to the place of beginning, containing 0.036 acres, more or less.

The above described area is within Auditors Permanent Parcel Number 010-249750.

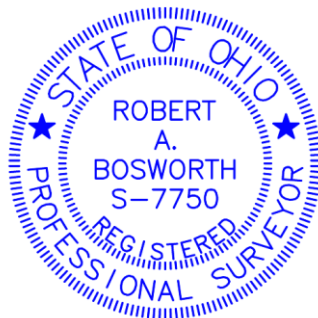
