This project consists of installing 177 Overhead LED Cobra Street Lights in South Westgate & Sylvan Roads area, and other such work as may be necessary to complete the contract, in accordance with the plans and specifications set forth in the Invitation for Bid (IFB).

The planning area for this project is the Hilltop area.

6. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**

Contract work is required to be completed in a manner acceptable to the City within 180 days from the date that a Notice To Proceed (NTP) is given by the City, approximately November 1, 2016.

Install LED overhead street lighting in South Westgate & Sylvan Roads area. This work is being performed with the City of Columbus goal to light every street.

The bid amount and proposed award amount is \$367,911.61, including a 10% construction contingency amount that will be utilized to fund needed and approved changes in the work.
