**DESCRIPTION OF 0.005 ACRES**  
**Temporary Easement**  
**LRC Morse Investors, LTD**  
**4401 Cleveland Ave**

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Township 1, Township 1 North, Range 18 West, United States Military Lands and being part of a 1.292 acres tract of land described in a deed to LRC Morse Investors, LTD by deed of reference in Instrument No. 199907090175218. All references to records herein are those located in the Recorder's Office of Franklin County, Ohio and being more particularly described as follows:

Commencing at the intersection of the southerly right of way line for Morse Road (width varies) with the westerly right of way for Cleveland Avenue (80' width) this location, said intersection being the northeast corner of a 0.474 acre tract of land described in a deed to Triple Net, LLC by deed of reference in Instrument No. 199906100148452;

Thence **S 03 degrees 44 minutes 10 seconds W** a distance **192.71 feet** with the westerly right of way line of Cleveland Avenue, the east line of said 0.474 acre tract and a portion of the grantor's east line to point;

Thence **N 86 degrees 15 minutes 50 seconds W** a distance **4.00 feet** across the grantor's tract to a point, said point being the *TRUE POINT OF BEGINNING*;

Thence **S 03 degrees 44 minutes 10 seconds W** a distance **5.00 feet** across the grantor's tract with a line being 4.00 feet west of and parallel with the westerly right of way line for Cleveland Avenue as measured by right angles to a point;

Thence **N 86 degrees 15 minutes 50 seconds W** a distance **9.00 feet** across the grantor's tract to a point; said point being 13.00 feet west of the westerly right of way line for Cleveland Avenue as measured by right angles;

Thence **S 03 degrees 44 minutes 10 seconds W** a distance **52.00 feet** across the grantor's tract with a line being 8.00 feet west of and parallel with the westerly right of way line for Cleveland Avenue as measured by right angles to a point;

Thence **N 86 degrees 15 minutes 50 seconds W** a distance **3.00 feet** across the grantor's tract to a point; said point being 11.00 feet west of the westerly right of way line for Cleveland Avenue as measured by right angles;

Thence **N 03 degrees 44 minutes 10 seconds E** a distance **57.00 feet** across the grantor's tract with a line being 16.00 feet west of and parallel with the westerly right of way line for Cleveland Avenue as measured by right angles to a point;

Thence **S 86 degrees 15 minutes 50 seconds E** a distance **12.00 feet** across the grantor's tract to the **TRUE POINT OF BEGINNING**, containing 0.005 acre of land more or less.

The above described area contains a total of **0.005 acres** within Franklin County Auditor's Parcel Number 010-249182-00, which includes 0.000 acres in the present road occupied.

Grantor claims title by Instrument recorded in Instrument No. 199907090175218 in the records of Franklin County, Ohio.

Bearings used in this description are based on Ohio State Plane Coordinate System, South Zone as per NAD 83 and were established utilizing ODOT's VRS System, GPS equipment and procedures and established bearing of N 03°44'10" E on the centerline of Cleveland Avenue.
