The Department of Public Utilities solicited Requests for Proposals for the Stormwater (ST-21, ST-22, and ST-23) Improvements Project.

The intent of this project is to provide the City of Columbus, Department of Public Utilities, Division of Stormwater with preliminary engineering services to investigate, develop, and evaluate storm system and flood protection improvements for the area southwest of the Arena District near the confluence of the Scioto and Olentangy Rivers that: 1) meet the current City of Columbus Stormwater Drainage Manual criteria; 2) eliminate structural flooding for storm events up to and including the 100-year event; and 3) protect from Scioto River 100-year flood event.

The project was formally advertised on the Vendor Services website from March 24, 2017 to April 21, 2017. The city received two (2) responses. Both proposals were deemed responsive and were fully evaluated when the Evaluation Committee met on May 2, 2017.
