The existing 1 million gallon Westgate East tank is approaching the end of its service life. The existing tank will be demolished and a new 2 million gallon elevated storage tank will be constructed. The project site is located within Westgate Park.

6. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**

The duration of the design phase for this project is approximately 12 months. Part of the Engineer's scope of work is to provide services during and record drawings after the construction of this project. Therefore the contract completion date cannot be determined at this time.

7. **A narrative discussing the economic impact or economic advantages of the project; community outreach or input in the development of the project; and any environmental factors or advantages of the project.**

By completing this project, the existing Westgate East 1-million gallon elevated storage tank will be replaced with a new 2-million gallon tank. The increase in elevated storage in the

Mound pressure district follows the recommendation of the Water Distribution Master Plan. The project will incorporate measures, such as energy efficient lighting, to reduce the energy demand of this facility.
