[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, Clinton Township, being in Quarter Township 4, Township 1, Range 18 West of the United States Military Lands, being a part of Lot 8 of Highway Park as recorded in Plat Book volume 14, page 9 (all document references are to the records of Franklin County unless otherwise stated), and being a **0.009 acre** parcel out of that tract known as Franklin County Auditor's **Parcel Number 010-074462** as conveyed to **Harry Sowers** (hereafter referred to as "Grantor") by the instrument filed as **Instrument Number 201408010099812**, and being more particularly described as follows:

Being a parcel of land lying on the left side of the existing centerline of right-of-way of Hudson Street (60' R/W – Public) and being more particularly described as follows:

BEGINNING at a point at the southeast corner of the Grantor, the southeast corner of the said Lot 8, the southwest corner of Lot 9 of the said Highway Park, the southwest corner of that tract conveyed to BB's Property, LLC, an Ohio Limited Liability Company by the instrument filed as Instrument Number 201206080081545, and on the existing northerly right-of-way line of Hudson Street, said point being 30.00 feet left of the centerline of right-of-way line of Hudson Street station 66+92.14, said point being the **TRUE POINT OF BEGINNING** of the parcel herein described;

Thence along the southerly line of the Grantor, the southerly line of the said Lot 8, and the said existing northerly right-of-way line of Hudson Street, **North 86 degrees 36 minutes 37 seconds West for a distance of 35.64 feet** to a point at the intersection of the said existing northerly right-of-way line of Hudson Street and a proposed Permanent easement, said point being 30.00 feet left of the centerline of right-of-way of Hudson Street station 66+56.50;

Thence crossing through the lands of the Grantor and along the said proposed Permanent easement, **North 41 degrees 33 minutes 22 seconds West for a distance of 7.06 feet** to a point on the westerly line of the Grantor, the westerly line of the said Lot 8, and on the easterly right-of-way line of Ontario Street (50' R/W – Public), said point being 35.00 feet left of the centerline of right-of-way of Hudson Street station 66+51.51;

Thence along the said Grantor's westerly line, the said westerly line of Lot 8, and the said easterly right-of-way line of Ontario Street, **North 03 degrees 29 minutes 52 seconds East for a distance of 11.25 feet** to a point being 46.25 feet left of the centerline of right-of-way of Hudson Street station 66+51.53

Thence crossing through the lands of the Grantor, the following four (4) courses:

1. **South 53 degrees 13 minutes 23 seconds East for a distance of 11.35 feet** to a point being 40.00 feet left of the centerline of right-of-way of Hudson Street station 66+61.01;
2. **South 83 degrees 51 minutes 41 seconds East for a distance of 10.43 feet** to a point being 39.50 feet left of the centerline of right-of-way of Hudson Street station 66+71.43;
3. **South 86 degrees 36 minutes 37 seconds East for a distance of 4.30 feet** to a point being 39.50 feet left of the centerline of right-of-way of Hudson Street station 66+75.73;

4. **South 71 degrees 17 minutes 19 seconds East for a distance of 17.03 feet** to a point on the Grantor's easterly line, the easterly line of the said Lot 8, on the westerly line of the said Lot 9, and on the westerly line of the said BB's Property, LLC, an Ohio Limited Liability Company tract, said point being 35.00 feet left of the centerline of right-of-way of Hudson Street station 66+92.15;

Thence along the said easterly line of the Grantor, the said easterly line of Lot 8, the said westerly line of Lot 9, and the said westerly line of the BB's Property, LLC, an Ohio Limited Liability Company tract, **South 03 degrees 30 minutes 42 seconds West for a distance of 5.00 feet** to the **TRUE POINT OF BEGINNING** of the parcel herein described.

The above description contains a total area of **0.009 acres (0.000 acres** are located within the Present Road Occupied resulting in a net take of **0.009 acres**), all of which are located within Franklin County Auditor's **Parcel Number 010-074462**.

Prior instrument of record as of this writing recorded in **Instrument Number 201408010099812** in the records of Franklin County.

This description was prepared by Andrew T. Jordan, Ohio Registered Professional Surveyor number 8759, and is based on an actual field survey conducted by American Structurepoint Inc., and is true and correct to the best of my knowledge and belief.

The bearing for this description are based on Grid North as referenced to South 86 degrees 18 minutes 11 seconds East for the centerline of right-of-way of Hudson Street east of Interstate Route 71 (FRA-1-25.33) as referenced to the Ohio State Plane coordinate system (South Zone) and the North American Datum of 1983, as established utilizing a GPS survey and NGS OPUS solution.

The stations referenced herein are from the plans known as Hudson Street on file with City of Columbus, Ohio having "E" plan number 3575.
