[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, located in Farm Lot 18 of Flavel Tuller's Survey of Quarter Township 1, Township 2 North, Range 19 West, United States Military Lands, as recorded in Plat Book 3, Page 60, and being a part of Lot 954 of the Olde Sawmill Section Nine Subdivision as recorded in Plat Book 60, Page 64, as conveyed to Sandhya Agarwal by deed of record in Instrument Number 200108290200133, all records of the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows:

Being a parcel of land located on the left side of the Plat of the Centerline of Right-of-Way of FRA-C.R. 61-1.10, as recorded in Plat Book____, Page____;

Beginning at a 1" iron pipe found marking the southeast corner of said Lot 954, being 200.00 feet left of Hard Road centerline station 127+47.96;

Thence North 87 degrees 39 minutes 05 seconds West, a distance of 17.96 feet along the southerly line of said Lot 954 to a point being 200.00 feet left of Hard Road centerline station 127+30.00;

Thence North 02 degrees 20 minutes 55 seconds East, a distance of 5.00 feet across said Lot 954 to a point being 205.00 feet left of Hard Road centerline station 127+30.00;

Thence South 87 degrees 39 minutes 05 seconds East, a distance of 17.96 feet across said Lot 954 to a point in the easterly line of said Lot 954, being 205.00 feet left of Hard Road centerline station 127+47.96;

Thence South 02 degrees 20 minutes 55 seconds West, a distance of 5.00 feet along the easterly line of said Lot 954 to the **Point of Beginning**, containing 0.002 acres, more or less;

Of the above described area, 0.002 acres is contained within the Franklin County Auditor's Parcel 590-195038.

The bearing datum of the afore-described parcel is based upon the Ohio State Plane Coordinate System, South Zone, NAD 1983 (1986 Adjustment), as measured using G.P.S. methods through the Franklin County Engineer's stations FRANK 74, FRANK 174, FCGS 7772, FCGS 6651, FCGS 2232, and FRANK 2218 RESET.
