This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the Pedestrian Safety Improvements - Joyce Avenue Sidewalks-Denune to Agler project.

Project Scope:

This project will construct sidewalks on the east and west sides of Joyce Avenue from Denune to Agler. The work includes concrete sidewalks, miscellaneous paving, grading, miscellaneous retaining walls, curb ramps, and other such work as may be necessary to complete the contract in accordance with the plans and specifications.

Fiscal Impact: Source of funds is 2013 Department of Public Service bonds.

Engineer's estimate + inspection (12%): \$354,245.58

Low bid amount + inspection (12%): \$323,366.12

Difference between engineer's estimate and bid amount, including inspection: \$30,879.46 under
