

PARCEL 33-T
TEMPORARY EASEMENT

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in ½ Section 30, Section 18, Township 12, Range 21, Refugee Lands, and being part of Lot 355 and the south half of a vacated 16 foot alley of East Minster Addition, as recorded in Plat Book 16, page 15, said Lot 355 and said vacated alley being described in a deed to **Thomas McDonald**, of record in Instrument Number 201304240067748, all records referenced herein are on file at the Office of the Recorder for Franklin County, Ohio, being a parcel on the left side of the proposed centerline of construction for James Road, as seen on the centerline plat for James Road, of record in Plat Book ____, page ____, said parcel being more particularly bounded and described as follows:

Commencing for reference at a railroad spike set at the intersection of the existing centerline of right-of-way for Livingston Avenue and the existing north centerline of right-of-way for James Road, being the southeast corner of said ½ Section 30, said point being 34.65 feet left of James Road proposed centerline of construction station 104+07.31;

Thence **North 04 degrees 27 minutes 26 seconds East**, along the existing north centerline of right-of-way for James Road and along the west line of said ½ Section 30, a distance of **510.12 feet** to an angle point, said point being 9.00 feet left of James Road proposed centerline of construction Station 109+09.33;

Thence **North 04 degrees 26 minutes 27 seconds East**, continuing along the existing centerline of right-of-way for James Road and continuing along the west line of said ½ Section 30, a distance of **259.75 feet** to a point, said point being 8.98 feet left of James Road proposed centerline of construction Station 111+69.08;

Thence **North 85 degrees 33 minutes 33 seconds West**, along a line perpendicular to the previous course, a distance of **35.00 feet** to a point on the existing west right-of-way line for said James Road, as established by said East Minster Addition, being the southeast corner of said Lot 355, being the northeast corner of Lot 354 of said East Minster Addition, as said Lot is described in a deed to James J. Gray, of record in Instrument Number 200909180136086, said point being 43.98 feet left of James Road proposed centerline of construction Station 111+69.08, and said point being the **TRUE POINT OF BEGINNING** for the herein described temporary easement;

Thence **North 85 degrees 33 minutes 34 seconds West**, along the south line of said Lot 355 and along the north line of said Lot 354, a distance of **6.00 feet** to a point, said point being 49.98 feet left of James Road proposed centerline of construction Station 111+69.08;

Thence **North 04 degrees 26 minutes 27 seconds East**, across said Lot 355 and across said vacated alley, a distance of **53.00 feet** to a point on the centerline of said vacated alley, being the north line of the grantor's land, and being the south line of a tract of land described in a deed to the City of Columbus, Ohio, of record in Instrument Number 201403130030482, said point being 49.97 feet left of James Road proposed centerline of construction Station 112+22.08;

Thence **South 85 degrees 33 minutes 34 seconds East**, along the centerline of said vacated alley, along the north line of the grantor's land and along the south line of said Columbus tract, a distance of **6.00 feet** to a point on the existing west right-of-way line for said James Road, being the northeast corner of the grantor's land, and being the southeast corner of said Columbus tract, said point being 43.97 feet left of James Road proposed centerline of construction Station 112+22.08;


Thence **South 04 degrees 26 minutes 27 seconds West**, along the existing west right-of-way line for said James Road, along the east line of said vacated alley and along the east line of said Lot 355, a distance of **53.00 feet** to the **TRUE POINT OF BEGINNING** for the herein described temporary easement.

The above described temporary easement contains a total area of **0.007 acres** located within Franklin County Auditor's parcel number 010-090578.

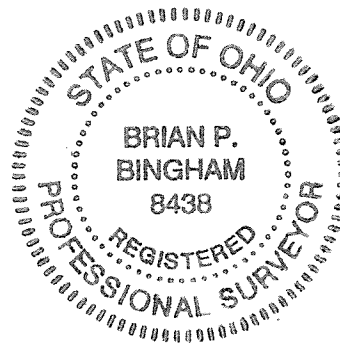
The bearings described herein are based on Grid North (reference South 85 degrees 47 minutes 50 seconds East for Livingston Avenue east of James Road) as referenced to the Ohio State Plane Coordinate System (South Zone) and the North American Datum of 1983 (CORS '96). As established utilizing a GPS survey referencing ODOT CORS stations "COLB", "OHLI" and "OHMD".
