Grantor/Owner, for himself and his heirs, executors, administrators, successors and assigns, reserves all existing rights of ingress and egress to and from any residual area (as used herein, the expression "Grantor/Owner" includes the plural, and words in the masculine include the feminine or neuter).

[Surveyor's description of the premises follows]

Situate in the State of Ohio, County of Franklin, City of Columbus, being located in Half Section 53 in original Truro Township, Township 12, Range 21 of the Refugee Lands. The herein described parcel lies on the left side of the existing centerline of right-of-way of Refugee Road. All bearings and distances, stations and offsets are based on the Right-of-Way plans prepared by Burgess & Niple for the City of Columbus as shown on the centerline plat for Refugee Road as recorded in Plat Book 125, pages 58 – 61 of the Franklin County Recorder's Office and as on file with the City of Columbus in plan 3419-E. Being part of lands conveyed to the "OH-UNIT GROUP LLC, AN OHIO LIMITED LIABILITY COMPANY" (hereafter referred to as Grantor) as described in Instrument No. 201710160143614 and 201802010014609 of the Franklin County Recorder's Office and being more particularly described as follows:

COMMENCING at the intersection of the existing centerlines of right-of-way of Refugee Road and Winchester Pike on the existing centerline of right-of-way of Refugee Road at station 10+01.07, also on the existing centerline of right-of-way of Winchester Pike at station 50+00.00, being witnessed by a monument box, located at the center of the box lid, North 85 deg. 43 min. 08 sec. West, 1.07 feet;

THENCE with the existing centerline of right-of-way of Refugee Road, **South 85 deg. 43 min. 08 sec. East** for a distance of **1044.62 feet** to the Southeast corner of a 0.3191 acre tract designated as Parcel No. 7 as appropriated by the City of Columbus in Franklin County Court of Common Pleas Case No. 231506 as recorded in Deed Book 2883 page 351 and the Southwest corner of a 0.1182 acre tract designated as Parcel No. 8 as conveyed to the City of Columbus in Deed Book 2869 page 252 on the existing centerline of right-of-way of Refugee Road at station 20+45.69;

THENCE, perpendicular with said centerline and with the common line between said Parcels No. 7 and 8, **North 04 deg. 16 min. 52 sec. East** for a distance of **50.00 feet** to northerly right-of-way line of Refugee Road, the Northwest corner of said Parcel No. 8, and the Grantor's Southwest corner at 50.00 feet left of the existing centerline of right-of-way of Refugee Road station 20+45.69 and the **TRUE POINT OF BEGINNING** of the herein described parcel;

THENCE with the northerly right-of-way line of Refugee Road, the east line of said Parcel No. 7, and the Grantor's West line, **North 04 deg. 16 min. 52 sec. East** for a distance of 10.00 feet to an **Iron Pin Set** at the Northeast corner of said Parcel No. 7 and the Southeast corner of lands conveyed to Refugee Road Staking, LLC, An Ohio Limited Liability Company at 60.00 feet left of the existing centerline of right-of-way of Refugee Road at station 20+45.69;

THENCE through the Grantor's lands, **South 85 deg. 43 min. 08 sec. East** for a distance of **103.02 feet** to an **Iron Pin Set** in the Northwest corner of a 0.116 acre tract conveyed to the City of Columbus as recorded in Deed Book 2869 page 255 on the northerly right-of-way line of Refugee Road and on the Grantor's East line at 60.00 feet left of the existing centerline of right-of-way of Refugee Road at station 21+48.69;

THENCE with West line of said 0.116 acre tract in the northerly right-of-way line of Refugee Road and the Grantor's East line, **South 04 deg. 25 min. 30 sec. West** for a distance of **10.00 feet** to the Northeast corner of said Parcel No. 8 in the northerly right-of-way line of Refugee Road and the Grantor's Southeast corner at 50.00 feet left of the existing centerline of Right-of-way of Refugee Road at station 21+48.69, being witness by an iron pin found South 36 deg. 59 min. 52 sec. East, 0.20 feet;

THENCE with the North line of said Parcel No. 8 in the northerly right-of-way line of Refugee Road and the Grantor's South line, **North 85 deg. 43 min. 08 sec. West** for a distance of **103.00 feet BACK TO THE TRUE POINT OF BEGINNING**.

The above-described parcel contains 0.024 acres total, including 0.000 acres in the present road occupied (PRO), lying in Franklin County Auditors parcel number 010-118474.

The basis of bearings for the above-described parcel are based on the Grid North and the Ohio State Plane Coordinate System, South Zone, NAD83(2011), as established from a GPS survey utilizing the Ohio Department of Transportation's Virtual Reference System (VRS), performed by OHM-Advisors in November, 2015 and as expressed on said Right-of-Way plans and Centerline Plat prepared by Burgess & Niple for the City of Columbus on the existing centerline of Refugee Road by a monument box, located at the center of the box lid, at station 10+00.00 and a 1" rebar set in pavement at the centerline intersections of Refugee Road and Schwartz Road at station 28+89.33 with a bearing of South 85 deg. 43 min. 08 sec. East.

All Iron Pins described as set are 5/8" x 30" rebar with a with a yellow plastic cap stamped "R/W Burgess & Niple" and shall be placed upon notification from the City of Columbus at the completion of construction.

This description was prepared by Burgess & Niple, under the direct supervision of Michael D. Jones, P.S., Ohio License No. 8459 and is based on a recent survey of the existing boundary monument locations performed by OHM Advisors, under the direction of John Raab, Professional Surveyor, Ohio License Number 7863, under a sub-consultant agreement between Burgess & Niple and OHM Advisors, for said services.
