Thence North 03°54'25" East, along said easterly right-of-way line, a distance of 135.03 feet to a point in the northerly line of said 0.534-acre tract located 30.00 feet RIGHT of station 78+39.09;

Thence South 85°27'21" East, along said northerly line, a distance of 5.00 feet to a point located 35.00 feet RIGHT of station 78+39.04;

South 03°54'25" West, parallel to said right-of-way line, a distance of 135.03 feet to a point in the northerly right-of-way line of Moler Road located 35.00 feet RIGHT of station 77+04.01;
