DESCRIPTION OF 0.010 ACRES
Proposed Right of Way
Samuel C. Guarini
3701 Cleveland Ave

Situated in the State of Ohio, County of Franklin, Clinton Township, being located in Quarter Township 1, Township 1 North, Range 18 West, United States Military Lands and being part of Lot 169 as the same is numbered and delineated upon the recorded plat Elmore Addition in Plat Book 9, Page 30 and described as Parcel 1 in a deed to Samuel C. Guarini by deed of reference in Instrument No. 200509300204856. All references to records herein are those located in the Recorder's Office of Franklin County, Ohio and being more particularly described as follows:

Commencing at the intersection of the northerly right of way line for Melrose Avenue (50' width) with the westerly right of way line for Cleveland Avenue (80' width) this location, said intersection also being the southeast corner of the grantor's tract (*said Lot 169*) and the **TRUE POINT OF BEGINNING**;

Thence **N 86 degrees 27 minutes 07 seconds W** a distance of **5.96 feet** with the northerly right of way line for Melrose Avenue and the south line of the grantor's tract (*said Lot 169*) to an iron pin set;

Thence **N 36 degrees 35 minutes 41 seconds E** a distance **11.01 feet** across the grantor's tract with a line being 5.00 feet west of and parallel with the westerly right of way line for Cleveland Avenue as measured by right angles to an iron pin set;

Thence **N 53 degrees 24 minutes 19 seconds W** a distance **7.00 feet** across the grantor's tract to a point, said point being 12.00 feet west of the westerly right of way line for Cleveland Avenue as measured by right angles;

Thence **N 36 degrees 35 minutes 41 seconds E** a distance **33.68 feet** across the grantor's tract with a line being 12.00 feet west of and parallel with the westerly right of way line for Cleveland Avenue as measured by right angles to an iron pin set;

Thence **S 53 degrees 24 minutes 19 seconds E** a distance **12.00 feet** across the grantor's tract to an iron pin set in the westerly right of way line of Cleveland Avenue, same being the easterly line of the grantor's tract (*said Lot 169*);

Thence **S 36 degrees 35 minutes 41 seconds W** a distance **41.43 feet** with the westerly right of way line for Cleveland Avenue and the easterly line of the grantor's tract (*said Lot 169*) to the **TRUE POINT OF BEGINNING**, containing 0.010 acre of land more or less.

The above described area contains a total of **0.010 acres** within Franklin County Auditor's Parcel Number 130-006964-00, which includes 0.000 acres in the present road occupied.

Grantor claims title by Instrument recorded in Instrument No. 200509300204856 in the records of Franklin County, Ohio.

Iron pins set, as shown on plan and in the above description are 5/8 inch steel rod, thirty (30) inches long with a cap stamped "Rii".

Bearings used in this description are based on Ohio State Plane Coordinate System, South Zone as per NAD 83 and were established utilizing ODOT's VRS System, GPS equipment and procedures and established bearing of N 36°35'41" E on the centerline of Cleveland Avenue.

This description was prepared from existing records and a field survey performed in August 2014.
