Thence North 26 Degrees 02 Minutes 19 Seconds West along said right of way line, a distance of 364.56 feet to a 5/8 inch by 30 inch rebar with cap "GPD" set on the Grantor's north line and the south line of a parcel conveyed to Norfolk Southern Railway Company, Instrument No. 200710260186473 (Successor by merger to Pennsylvania Line, LLC, Instrument No. 200212180325195), said rebar being 50.00 feet right of Sta. 639+48.14 of the centerline of right of way of U.S. Route 33 (Dublin Rd.);

Thence east along said line and with a non-tangential curve to the right having a radius of 1392.69 feet, a central angle of 02 Degrees 27 Minutes 14 Seconds, a chord bearing South 83 Degrees 00 Minutes 19 Seconds East, a chord distance of 59.64 feet, an arc length of 59.65 feet to a point on the centerline of U.S. Route 33 (Dublin Rd.) and the northeast corner of the Grantor's parcel, said point being at Sta. 639+77.90 of the centerline of right of way of U.S. Route 33 (Dublin Rd.);

6. Thence **South 26 Degrees 02 Minutes 19 Seconds East** along the centerline of said U.S. Route 33 (Dublin Rd.) and the Grantor's east line, a distance of **332.05 feet** to a point being at Sta. 643+12.70 of the centerline of right of way of U.S. Route 33 (Dublin Rd.);

Thence southeast continuing along said centerline and with a tangential curve to the right having a radius of **1432.39 feet**, a central angle of **10 Degrees 15 Minutes 56 Seconds**, a chord bearing **South 20 Degrees 54 Minutes 21 Seconds East**, a chord distance of **256.30 feet**, an arc length of **256.64 feet** to the Grantor's southeast corner, said corner being at Sta. 645+69.34 of the centerline of right of way of U.S. Route 33 (Dublin Rd.), on the original centerline of West Fifth Avenue and the original Perry/Franklin Township line;
