

PARCEL 21-T
TEMPORARY EASEMENT

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in ½ Section 29, Section 18, Township 12, Range 21, Refugee Lands, and being part of Lot 3 of Schaffner's Addition, as recorded in Plat Book 22, page 84, as said Lot is described in a deed to **Patrice Myers**, of record in Official Record 14952, page E15, all records referenced herein are on file at the Office of the Recorder for Franklin County, Ohio, being a parcel on the right side of the proposed centerline of construction for James Road, as seen on the centerline plat for James Road, of record in Plat Book ____, page ____, said parcel being more particularly bounded and described as follows:

Commencing for reference at a railroad spike set at the intersection of the existing centerline of right-of-way for Livingston Avenue and the existing north centerline of right-of-way for James Road, being the southwest corner of said ½ Section 29, said point being 34.65 feet left of James Road proposed centerline of construction station 104+07.31;

Thence **North 04 degrees 27 minutes 26 seconds East**, along the existing north centerline of right-of-way for James Road and along the west line of said ½ Section 29, a distance of **333.69 feet** to a point, said point being 9.00 feet left of James Road proposed centerline of construction Station 107+32.90;

Thence **South 85 degrees 32 minutes 34 seconds East**, along a line perpendicular to the previous course, a distance of **39.88 feet** to a point on the existing east right-of-way line for said James Road, as established by said Schaffner's Addition, being the southwest corner of said Lot 3, and being the northwest corner of Lot 4 of said Schaffner's Addition, as said Lot is described in a deed to Charles K. Slaughter, Sr. and Justine Slaughter, of record in Instrument Number 200302070039872, said point being 30.88 feet right of James Road proposed centerline of construction Station 107+32.90;

Thence **South 85 degrees 39 minutes 58 seconds East**, along the south line of said Lot 3 and along the north line of said Lot 4, a distance of **7.00 feet** to an iron pin set on the proposed east right-of-way line for said James Road, said iron pin set being 37.88 feet right of James Road proposed centerline of construction Station 107+32.91, and said iron pin set being the **TRUE POINT OF BEGINNING** for the herein described temporary easement;

Thence **North 04 degrees 30 minutes 02 seconds East**, along the proposed east right-of-way line for said James Road and across said Lot 3, a distance of **54.18 feet** to an iron pin set on the north line of said Lot 3, being the south line of Lot 2 of said Schaffner's Addition, as said Lot is described in a deed to Jean Ann Gloeckner, of record in Deed Book 3769, page 308, said iron pin set being 37.92 feet right of James Road proposed centerline of construction Station 107+87.09;

Thence **South 85 degrees 39 minutes 58 seconds East**, along the north line of said Lot 3 and along the south line of said Lot 2, a distance of **26.22 feet** to a point, said point being 63.76 feet right of James Road proposed centerline of construction Station 107+87.12;

Thence across said Lot 3 along the following four (4) described courses:

1. **South 74 degrees 37 minutes 14 seconds West**, a distance of **19.38 feet** to a point, said point being 45.91 feet right of James Road proposed centerline of construction Station 107+80.57;
2. **South 04 degrees 30 minutes 02 seconds West**, a distance of **29.05 feet** to a point, said point being 45.89 feet right of James Road proposed centerline of construction Station 107+51.52;
3. **South 74 degrees 58 minutes 23 seconds East**, a distance of **20.18 feet** to a point, said point being 65.72 feet right of James Road proposed centerline of construction Station 107+47.84;
4. **South 04 degrees 29 minutes 50 seconds West**, a distance of **14.85 feet** to a point on the south line of said Lot 3, being the north line of said Lot 4, said point being 65.71 feet right of James Road proposed centerline of construction Station 107+32.97;

Thence **North 85 degrees 39 minutes 58 seconds West**, along the south line of said Lot 3 and along the north line of said Lot 4 a distance of **27.84 feet** to the **TRUE POINT OF BEGINNING** for the herein described temporary easement.


The above described temporary easement contains a total area of **0.019 acres** located within Franklin County Auditor's parcel number 010-095780.

The bearings described herein are based on Grid North (reference South 85 degrees 47 minutes 50 seconds East for Livingston Avenue east of James Road) as referenced to the Ohio State Plane Coordinate System (South Zone) and the North American Datum of 1983 (CORS '96). As established utilizing a GPS survey referencing ODOT CORS stations "COLB", "OHLI" and "OHMD".


Iron pins set are 30" by 5/8" diameter rebar with caps stamped "American Structurepoint PS 8438".
