PROPOSED SCOPE OF SUPPLY C0161565 Southerly Water Reclamation

Patterson Pump Company is providing a quote to Southerly Water Reclamation for a replacement rotating assembly of the Patterson pump model F42 complete, including the Chesterton mechanical seal. The quote will be presented to the plant through our local representative Sabatka Davis & Associates, Inc. (SDA). SDA has been Patterson's local representative for 38 years and has been involved with this pump station since the purchase of the pumps installed on site.

The rotating assembly will be completely built and ready for installation into the pump. The site will not be require to perform any modification or adjustments to the rotating assembly during installation. The mechanical seal will be shipped loose to prevent it from being damaged. The seal will need to be installed once the rotating assembly is fully installed into the pump casing.

Patterson is offering our standard 12 month from installation or 18 month form shipment warranty on this rotating assembly. No other warranty or extension is being offered for this.

The rotating assembly will be built at Patterson and shipped direct to the site. The freight cost for this delivery is included in this bid. The site will be responsible for the off loading and handling of the rotating assembly.

Patterson is not offering any site services to require the need for insurance or workers compensation to be supplied.

The rotating assembly is of the original design where there is not any required modifications to the originally supplied manuals. Patterson is not offering to supply any additional manuals with the rotating assembly.

Patterson quote has an estimated lead time to complete and ship the rotating assembly. Patterson will do everything possible to meet this lead time, but does not guarantee this time for shipment. Once the PO is received, the parts will be purchased and labor work will be scheduled based on the scheduled receipt of all parts and current production work load.
