Situated in the State of Ohio, County of Franklin, City of Columbus, Quarter Township 3, Township 1 North, Range 16 West, United States Military District Lands, being a portion of Lot 2 as delineated one the plat Columbus Industrial Park, of record in Plat Book 48, Page 79 and being part of a 2.964 acre tract of land in the name of DAMASCUS COMPANY LTD., an Ohio limited liability company as described in Instrument Number 199807130174488, all records are on file in the Franklin County Recorder's Office, and being a tract of land lying on the left side of the centerline of Right-of-Way of State Route 16 (East Broad Street) (R/W Varies) and is more particularly described as follows:
