Jacqueline Miles is a second-generation Franklintonian living north of Broad St. She was a proactive community member *long* before she served as the Franklinton Area Commission Chair (FAC) for the last six years. Jacqueline founded Three Women & A Shovel in 2015 with two neighbors to revive her parent's legacy of The Helping Hands Club from the 1960s. The goal was to assist 10 elders with beautifying their yards. Ms. Miles collaborated with Lowes, Xenos, The Refuge, other volunteer groups and individuals to surpass her initial vision. Mission accomplished! Her block boasted 4 - 6 sites on the Franklinton Garden & Art Tours for the five years that it ran. Her volunteer effort continues with winning awards with The Litter League, coordinating litter pickups, hosting a Little Free Library and ongoing beautification.

As FAC Chair, Jackie led by example to get informed and get involved.

She has been active with the Housing, Planning and Zoning committees, worked closely with city officials and residents. She is quick to use her networking and collaboration skills to help Franklintonian who contact her for resources and direction. Jackie regularly attends local events such as house openings for Franklinton Rising, Lower Lights Ministries Galas, Franklinton Board of Trade Auctions and other not-for -profits events to stay abreast of news and needs. Most recently, she spearheaded the retirement party for Bruce Warner and Judy Box, long-time Commissioners, and neighborhood volunteers hosted at Cover My Meds.

Ms. Miles values our neighborhood history and wants us to have a brighter future here in the Franklinton area and better lives of the community, one block at a time.

She shows up and works through items as put forth by the Commission and neighbors. Throughout her tenure she led by example encouraging all Commissioners to be active on committees and projects, attend City Council Meetings and go to the training classes (as she did) required to be a functional Commissioner working to *resolve issues* - not just to talk about them in a meeting.
