Yes - The lack of competition may have contributed to a higher than expected bid. However, I do not consider this to be a materially unbalanced bid. I attribute the significant difference between bid and estimate to a poorly prepared engineer's opinion of probable cost.

Yes- The uniqueness of the project precludes comparisons to similar projects.
