

**PARCEL 51-T**  
**TEMPORARY EASEMENT**

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in ½ Section 30, Section 18, Township 12, Range 21, Refugee Lands, and being part of Lot 364 of East Minster Addition, as recorded in Plat Book 16, page 15, as said Lot is described in a deed to **Saleh Hussain Alshatti**, of record in Instrument Number 201312060200781, all records referenced herein are on file at the Office of the Recorder for Franklin County, Ohio, being a parcel on the left side of the proposed centerline of construction for James Road, as seen on the centerline plat for James Road, of record in Plat Book \_\_\_\_, page \_\_\_\_, said parcel being more particularly bounded and described as follows:

Commencing for reference at a railroad spike set at the intersection of the existing centerline of right-of-way for Livingston Avenue and the existing north centerline of right-of-way for James Road, being the southeast corner of said ½ Section 30, said point being 34.65 feet left of James Road proposed centerline of construction station 104+07.31;

Thence **North 04 degrees 27 minutes 26 seconds East**, along the existing north centerline of right-of-way for James Road and along the west line of said ½ Section 30, a distance of **510.12 feet** to an angle point, said point being 9.00 feet left of James Road proposed centerline of construction Station 109+09.33;

Thence **North 04 degrees 26 minutes 27 seconds East**, continuing along the existing centerline of right-of-way for James Road and continuing along the west line of said ½ Section 30, a distance of **710.75 feet** to a point, said point being 8.94 feet left of James Road proposed centerline of construction Station 116+20.08;

Thence **North 85 degrees 33 minutes 33 seconds West**, along a line perpendicular to the previous course, a distance of **35.00 feet** to a point on the existing west right-of-way line for said James Road, as established by said East Minster Addition, being the southeast corner of said Lot 364, being the northeast corner of Lot 363 of said East Minster Addition, as said Lot is described in a deed to Oliver Everhart, of record in Official Record 26079, page F06, said point being 43.94 feet left of James Road proposed centerline of construction Station 116+20.08, and said point being the **TRUE POINT OF BEGINNING** for the herein described temporary easement;

Thence **North 85 degrees 33 minutes 34 seconds West**, along the south line of said Lot 364 and along the north line of said Lot 363, a distance of **4.00 feet** to a point, said point being 47.94 feet left of James Road proposed centerline of construction Station 116+20.08;

Thence **North 09 degrees 00 minutes 52 seconds East**, across said Lot 364, a distance of **50.16 feet** to a point on the existing west right-of-way line for said James Road, being the northeast corner of said Lot 364, and being the southeast corner of Lot 365 of said East Minster Addition, as said Lot is described in a deed to Joshua's Integrity, LLC, of record in Instrument Number 200809110137815, said point being 43.93 feet left of James Road proposed centerline of construction Station 116+70.08;

Thence **South 04 degrees 26 minutes 27 seconds West**, along the existing west right-of-way line for said James Road and along the east line of said Lot 364, a distance of **50.00 feet** to the **TRUE POINT OF BEGINNING** for the herein described temporary easement.

The above described temporary easement contains a total area of **0.002 acres** located within Franklin County Auditor's parcel number 010-090587.

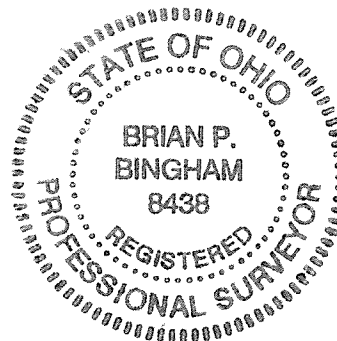
The bearings described herein are based on Grid North (reference South 85 degrees 47 minutes 50 seconds East for Livingston Avenue east of James Road) as referenced to the Ohio State Plane Coordinate System (South Zone) and the North American Datum of 1983 (CORS '96). As established utilizing a GPS survey referencing ODOT CORS stations "COLB", "OHLI" and "OHMD".
