

**0.062 ACRE SANITARY SEWER EASEMENT
DYER-LAZAR HSTS ELIMINATION

Situated in the State of Ohio, County of Franklin, Township of Jackson, Virginia Military Survey Number 4641, being part of a 1.532 acre tract conveyed to Conley Newsome, Trustee of the Trust of Conley Newsome as Parcel VI in Instrument Number 200610050199299, all records being of record in the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows:

COMMENCING from FCGS 6111, being a bronze disk in PVC encased concrete monument, being at the centerline of Dyer Road (R/W varies);

Thence along the centerline of said Dyer Road, South 87°39'38" East, 934.95 feet to a point, being the northeasterly corner of a 1.5 acre tract conveyed to Matthew C. Fleece in Instrument Number 201108020095758 and the northwesterly corner of said 1.532 acre tract;

Thence across said Dyer Road, along the easterly line of said 1.5 acre tract and the westerly line of said 1.532 acre tract, South 01°07'22" West, 363.64 feet to a point, said point being the **TRUE POINT OF BEGINNING**:

Thence across said 1.532 acre tract, south 79°46'59" East, 101.96 feet to a point, being on the easterly line of said 1.532 acre tract and the westerly line of a 2.509 acre tract conveyed to Janice M. Conway in Instrument Number 201405210063190;

Thence along the easterly line of said 1.532 acre tract and the westerly line of said 2.509 acre tract, South 06°21'22" West, 52.08 feet to a point;

Thence across said 1.532 acre tract, the following two (2) courses:

North 18°16'43" West, 30.68 feet to a point;

North 79°46'59" West, 86.83 feet to a point, being on the westerly line of said 1.532 acre tract and the easterly line of said 1.5 acre tract;

Thence along the westerly line of said 1.532 acre tract and the easterly line of said 1.5 acre tract, North 01°07'22" East, 25.32 feet to a point, said point being the **POINT OF TRUE BEGINNING**, containing 0.062 acres (2,693 S.F.), more or less.

Subject however to all legal easements, restrictions and rights of way of record and of records in the respective utility offices.

Bearings referenced herein are based on a portion of the centerline of Dyer Road as being North 87°39'38" West as determined by GPS observations utilizing Ohio Department of Transportation's Virtual Reference Station, based on Ohio State Plane South Zone (NAD 83, 2011 adjustment).
