Sir,

The following investigation was conducted concerning the City of Columbus' 2020 annual objection to the renewal of liquor permit **7640081** issued to **S EMAN INC**, which is doing business as **Convenient Plus Food Mart** located at **1541 Frebis Ave.**, **Columbus**, **Ohio 43206**. The recorded owner of said permit is **Zubeeda Khanam**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio. The City of Columbus objected to this liquor permit renewal at the end of 2019, and, while a hearing has been held concerning this permitholder, there has not yet been a final decision on this permit. Thus, an objection of the 2020 renewal is proper in order to preserve any objection to its continued renewal while the Division of Liquor Control waits to issue its decision.

The above listed liquor establishment has been issued a **C1 and C2** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.
