[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, located in Farm Lot 15 of Flavel Tuller's Survey of Quarter Township 1, Township 2 North, Range 19 West, United States Military Lands, as recorded in Plat Book 3, Page 60, and being a part of Lot 20 of the Kilbourne Estates Subdivision as recorded in Plat Book 78, Page 8, as conveyed to Donald L. Shaw by deeds of record in Instrument Number 200009060179661 and Instrument Number 200201290027021, all records of the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows:

Being a parcel of land located on the left side of the Plat of the Centerline of Right-of-Way of FRA-C.R. 61-1.10, as recorded in Plat Book____, Page____;

Beginning at a 1" iron pipe found marking the southwest corner of said Lot 20, being 40.00 feet left of Hard Road centerline station 150+23.26;

Thence North 02 degrees 20 minutes 11 seconds East, a distance of 10.00 feet along the westerly line of said Lot 20 to a point being 50.00 feet left of Hard Road centerline station 150+23.25;

Thence South 87 degrees 38 minutes 42 seconds East, a distance of 108.75 feet across said Lot 20 to a point being 50.00 feet left of Hard Road centerline station 151+32.00;

Thence North 02 degrees 21 minutes 18 seconds East, a distance of 70.00 feet across said Lot 20 to a point in the northerly line of said Lot 20, being 120.00 feet left of Hard Road centerline station 151+32.00;

Thence South 87 degrees 38 minutes 42 seconds East, a distance of 20.32 feet along the northerly line of said Lot 20 to a 1" iron pipe found marking the northeast corner of said Lot 20, being 120.00 feet left of Hard Road centerline station 151+52.32;

Thence South 02 degrees 21 minutes 18 seconds West, a distance of 50.00 feet along the existing westerly Right-of-Way line of Schoolway Court, and along the easterly line of said Lot 20 to an iron pin set being 70.00 feet left of Hard Road centerline station 151+52.32;

Thence along the arc of a curve to the right for 47.12 feet across said Lot 20, and along the proposed northerly Right-of-Way line of Hard Road, having a radius of 30.00 feet, a central angle of 90 degrees 00 minutes 00 seconds, a chord bearing of South 47 degrees 21 minutes 18 seconds West, a chord distance of 42.43 feet to an iron pin set at the intersection with the existing northerly Right-of-Way line of Hard Road, being 40.00 feet left of Hard Road centerline station 151+22.32;

Thence North 87 degrees 38 minutes 42 seconds West, a distance of 99.06 feet along the southerly line of said Lot 20, and along the existing northerly Right-of-Way line of Hard Road, to the **Point of Beginning**, containing 0.058 acres, more or less;

Of the above described area, 0.058 acres is contained within the Franklin County Auditor's Parcel 610-224802.

The bearing datum of the afore-described parcel is based upon the Ohio State Plane Coordinate System, South Zone, NAD 1983 (1986 Adjustment), as measured using G.P.S. methods through the Franklin County Engineer's stations FRANK 74, FRANK 174, FCGS 7772, FCGS 6651, FCGS 2232, and FRANK 2218 RESET.

This description was based upon an actual field survey of Hard Road by Stantec Consulting Services, Inc., in October and November of 2010, under the direction of Tim A. Baker, Registered Surveyor Number 7818.

Iron Pins Set are 3/4 inches in diameter by 30 inches long with a 2 inch aluminum cap placed on top bearing the name "ODOT R/W" and "STANTEC".
