The above listed liquor establishment has been issued a liquor permit from the Division of Liquor Control # 8831636-0005 . The permit holder received a D - 5 permit. This permit grants the permit holder the privilege to sell alcoholic beverages in the State of Ohio for on premise consumption as described by law.
