

**TEMPORARY CONSTRUCTION EASEMENT  
PARCEL 47-T2  
0.0025 ACRE TRACT (108.9 S.F.)  
EXHIBIT "A"**

Situate in the City of Columbus, County of Franklin, State of Ohio, Virginia Military Survey No. 971, being part of Lot No. 341 of Westland Addition Extension Subdivision as recorded in Plat Book 18, Page 40 and conveyed to Joanne S. Taddeo by deed recorded in Instrument No. 200107110157553 (all references to deeds, microfiche, plats, surveys, etc. refer to the records of the Franklin County Recorder's Office, unless noted otherwise) and being more particularly bounded and described as follows:

Commencing for reference at the southeast corner of said Lot No. 341, being at the intersection of the north right of way line of Mound Street (50' public right of way, originally dedicated as Dartmoor Road, see City of Columbus Ordinance No. 196-43) with the west right of way line of Terrace Avenue (50' public right of way);

thence along the east line of said Lot No. 341 and the west right of way line of said Terrace Avenue, North thirteen degrees five minutes three seconds East (N13°05'03"E) for ten and 27/100 feet (10.27') to the **TRUE POINT OF BEGINNING** of the herein described tract of land;

thence leaving said lines across said Lot No. 341, South fifty-eight degrees six minutes fifty-one seconds West (S58°06'51"W) for seven and 7/100 feet (7.07');

thence continuing across said Lot No. 341, North thirteen degrees five minutes three seconds East (N13°05'03"E) for twenty-four and 28/100 feet (24.28');

thence continuing across said Lot No. 341, South seventy-six degrees fifty-four minutes fifty-seven seconds East (S76°54'57"E) for five and 00/100 feet (5.00') to the east line of said Lot No. 341 and the west right of way line of said Terrace Avenue;

thence along said lines, South thirteen degrees five minutes three seconds West (S13°05'03"W) for nineteen and 28/100 feet (19.28') to the **TRUE POINT OF BEGINNING**, containing 0.0025 acres (108.9 S.F.), more or less, subject however to all covenants, conditions, restrictions, reservations and easements contained in any instrument of record pertaining to the above described tract of land.

Bearings are based upon the Ohio State Plane Coordinate System, South Zone, NAD83 (2007). Said bearings originated from said coordinate system by GPS observations and observations of Franklin County Survey Monuments 5/14 and COC 1-83. The portion of the centerline of Mound Street stretching west to east from Binns Boulevard to Ogden Avenue, having a bearing of S81°45'59"E, is designated the "Basis of Bearing" for this description.

This description was prepared under the direction of Cody Schneider, Ohio Registered Surveyor No. 8670, of Woolpert Inc., and is based on a field survey performed during February and March, 2013, as well as February, 2016.
