Situated in the State of Ohio, City of Columbus, Franklin County, Quarter Township No. 4, Township 2N, Range 17W, U.S. Military District and being part of a 71.846 acre tract conveyed to Firewater Limited, an Ohio Limited Liability Company in Instrument 201504170049716 in the Franklin County Recorder's Office. The below described parcel laying on the right and left side of the Big Walnut Trail North Section, and being more particularly described as follows:
