Commencing for reference at a railroad spike set at the intersection of the existing centerline of right-of-way for James Road and the existing centerline of right-of-way for Main Street, being on the west line of said ½ Section 29, said point being on James Road proposed centerline of construction Station 139+39.77;

Thence South 04 degrees 02 minutes 28 seconds West, along the existing centerline of right-of-way for James Road and along the west line of said ½ Section 29, a distance of 687.48 feet to a point, said point being 8.14 feet left of James Road proposed centerline of construction Station 132+51.85;

Thence South 85 degrees 57 minutes 32 seconds East, along a line perpendicular to the previous course, a distance of 30.00 feet to a point on the existing east right-of-way line for said James Road, as established by said Caldwell Main Street Addition, being the grantor's southwest corner, and being the northwest corner of a tract of land described in a deed to Linda F. Thence South 87 degrees 54 minutes 14 seconds East, along the grantor's south line and along the north line of said Murrell tract, a distance of 16.86 feet to an iron pin set on the proposed east right-of-way line for said James Road, said iron pin set being 38.71 feet right of James Road proposed centerline of construction Station 132+52.67, and said iron pin set being the TRUE POINT OF BEGINNING for the herein described temporary easement;

Thence North 04 degrees 03 minutes 12 seconds East, along the proposed east right-of-way line for said James Road and across said Lot 19, a distance of 40.00 feet (passing the north line of said Lot 19 at a distance of 20.00 feet, being the south line of said Lot 18) to an iron pin set on the grantor's north line, being the south line of a tract of land described in a deed to Javonna D. Green, of record in Official Record 31980, page A19, said iron pin set being 38.51 feet right of James Road proposed centerline of construction Station 132+92.67;

Thence South 87 degrees 54 minute 38 seconds East, along the grantor's north line and along the south line of said Green tract, a distance of 28.65 feet to a point, said point being 67.14 feet right of James Road proposed centerline of construction Station 132+93.79;

Thence South 50 degrees 06 minutes 03 seconds West, across said Lot 18, a distance of 29.88 feet to a point on the south line of said Lot 8, being the north line of said Lot 19, said point being 45.73 feet right of James Road proposed centerline of construction Station 132+72.95;

Thence South 46 degrees 03minutes 37 seconds East, across said Lot 19, a distance of 12.71 feet to a point, said point being 55.53 feet right of James Road proposed centerline of construction Station 132+64.84;

Thence South 03 degrees 38 minutes 37 seconds West, continuing across said Lot 19, a distance of 11.52 feet to a point on the grantor's south line, being the north line of said Murrell tract, said point being 55.67 feet right of James Road proposed centerline of construction Station 132+53.33;

Thence North 87 degrees 54 minutes 14 seconds West, along the grantor's south line and along the north line of said Murrell tract, a distance of 16.97 feet to the TRUE POINT OF BEGINNING for the herein described temporary easement.
