[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, located in Farm Lot 18 of Flavel Tuller's Survey of Section 1, Township 2 North, Range 19 West, United States Military Lands, as recorded in Plat Book 3, Page 60, and being a part of Lot 993 of the Olde Sawmill Section Nine Subdivision as recorded in Plat Book 60, Page 64, as conveyed to David A. Linville and Teresa K. Linville by deed of record in Official Record 11840 G13, all records of the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows:

Being a parcel of land located on the left side of the Plat of the Centerline of Right-of-Way of FRA-C.R. 61-1.10, as recorded in Plat Book____, Page____;

Beginning at a 5/8" iron pin found marking the southeast corner of said Lot 993, being 40.00 feet left of Hard Road centerline station 135+11.96;

Thence North 87 degrees 39 minutes 05 seconds West, a distance of 80.34 feet along the southerly line of said Lot 993, and along the existing northerly Right-of-Way line of Hard Road, to an iron pin set at the intersection with the proposed northerly Right-of-Way line of Hard Road, being 40.00 feet left of Hard Road centerline station 134+31.62;

Thence North 02 degrees 20 minutes 55 seconds East, a distance of 5.00 feet across said Lot 993, and along the proposed northerly Right-of-Way line of Hard Road, to an iron pin set being 45.00 feet left of Hard Road centerline station 134+31.62;

Thence North 87 degrees 39 minutes 05 seconds West, a distance of 84.85 feet across said Lot 993, and along the proposed northerly Right-of-Way line of Hard Road, to an iron pin set at the intersection with the westerly line of said Lot 993, being 45.00 feet left of Hard Road centerline station 133+46.77;

Thence North 22 degrees 16 minutes 42 seconds East, a distance of 5.32 feet along the westerly line of said Lot 993 to a point being 50.00 feet left of Hard Road centerline station 133+48.58;

Thence South 87 degrees 39 minutes 05 seconds East, a distance of 157.99 feet across said Lot 993 to a point in the easterly line of said Lot 993, being 50.00 feet left of Hard Road centerline station 135+06.57;

Thence South 25 degrees 57 minutes 56 seconds East, a distance of 11.36 feet along the easterly line of said Lot 993 to the **Point of Beginning**, containing 0.027 acres, more or less;

Of the above described area, 0.027 acres is contained within the Franklin County Auditor's Parcel 590-195077.

The bearing datum of the afore-described parcel is based upon the Ohio State Plane Coordinate System, South Zone, NAD 1983 (1986 Adjustment), as measured using G.P.S. methods through the Franklin County Engineer's stations FRANK 74, FRANK 174, FCGS 7772, FCGS 6651, FCGS 2232, and FRANK 2218 RESET.

This description was based upon an actual field survey of Hard Road by Stantec Consulting Services, Inc., in October and November of 2010, under the direction of Tim A. Baker, Registered Surveyor Number 7818.

Iron Pins Set are 3/4 inches in diameter by 30 inches long with a 2 inch aluminum cap placed on top bearing the name "ODOT R/W" and "STANTEC".
