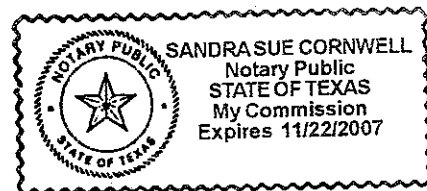

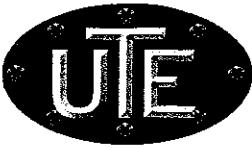

Utility Truck Equipment, Inc. would like to officially respond to your letter dated January 25, 2007 pertaining to *Sole Source* providers. In your correspondence, you asked UTE to explain why we would qualify as a Sole Source provider. Our answer is as follows:

Utility Truck Equipment, Inc. is the sole authorized distributor of Versalift Aerial Lift Devices and parts for the Columbus Metro Area. (I have asked Versalift to send a verification letter per your request)

Utility Truck Equipment, Inc. is the sole authorized warranty repair facility for Versalift Aerial Lift products for the Columbus Metro Area. (The letter from Versalift should also substantiate this claim)

Utility Truck Equipment, Inc. also produced all of the Teco Aerial Devices that the City of Columbus presently owns. Teco went bankrupt several years ago, but UTE can still provide parts and service for these machines we sold to the City of Columbus. At the time of sale, Utility Truck Equipment, Inc. was the sole distributor of these products.
