Two 55 Ft. Bucket Trucks

The Purchasing Office opened formal bids on September 4, 2008 for the purchase of Two (2) 55 foot Bucket Trucks for the Division of Power and Water. Three (3) bids were received.

Altec was the apparent low bid of \$167,140.00 each. They, however, did not meet specifications.

The unit failed to meet:

- 3.3.16.1 -Two sets of keys shall be provided. We requested three.
- 3.3.17.9 -Lower boom is rectangular in shape, upper boom is round. We requested both booms to be rectangular.
- 3.3.17.11 -Upper boom isolation gap is 162", meets Category "C" rating. We requested 239" of isolation gap.
- 3.3.19.2 -Electric-over hydraulic controls at tailshelf. All valves in pedestal for simplified hydraulic routing. We requested individual control valves on each side of tailshelf.
- 3.3.20.5 -Triangular hydraulic tank in corner of cargo area. We requested that the storage be an integral part of pedestal.
- 3.3.30.3 -They are offering a one day mechanic training class in conjunction with training that they are providing to American Electric Power (AEP). We requested more enhanced training where our technicians travel to the actual manufacturer facility for service schooling/certification.
