Situated in the State of Ohio, County of Franklin, City of Columbus, located in Farm Lot 15 of Flavel Tuller's Survey of Section 1, Township 2 North, Range 19 West, United States Military Lands, as recorded in Plat Book 3, Page 60, and being a part of that 0.972 acre tract as conveyed to RVAP Holdings, LLC, by deed of record in Instrument Number 201207170101839, all records of the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows:

Being a parcel of land located on the left side of the Plat of the Centerline of Right-of-Way of FRA-C.R. 61-1.10, as recorded in Plat Book____, Page____;

Beginning at a point in the southerly line of said RVAP 0.972 acre tract in the northerly line of that 0.162 acre tract as conveyed to the City of Columbus by deed of record in Official Record 32827 J02, and in the existing northerly Right-of-Way line of Hard Road, being 50.00 feet left of Hard Road Centerline Station 159+50.00;

Thence North 41 degrees 00 minutes 54 seconds East, a distance of 32.02 feet across said RVAP 0.972 acre tract to a point being 75.00 feet left of Hard Road Centerline Station 159+70.00;

Thence South 87 degrees 38 minutes 42 seconds East, a distance of 50.00 feet across said RVAP 0.972 acre tract to a point being 75.00 feet left of Hard Road Centerline Station 160+20.00;

Thence South 36 degrees 18 minutes 17 seconds East, a distance of 32.02 feet across said RVAP 0.972 acre tract to a point being 50.00 feet left of Hard Road Centerline Station 160+40.00;

Thence North 87 degrees 38 minutes 42 seconds West, a distance of 90.00 feet along the southerly line of said RVAP 0.972 acre tract, along the northerly line of said City of Columbus 0.162 acre tract, and along the existing northerly Right-of-Way line of Hard Road, to the **Point of Beginning**, containing 0.040 acres, more or less;

Of the above described area, 0.040 acres is contained within the Franklin County Auditor's Parcel 610-241324.

The bearing datum of the afore-described parcel is based upon the Ohio State Plane Coordinate System, South Zone, NAD 1983 (1986 Adjustment), as measured using G.P.S. methods through the Franklin County Engineer's stations FRANK 74, FRANK 174, FCGS 7772, FCGS 6651, FCGS 2232, and FRANK 2218 RESET.

This description was based upon an actual field survey of Hard Road by Stantec Consulting Services, Inc., in October and November of 2010, under the direction of Tim A. Baker, Registered Surveyor Number 7818.
