

MODIFICATION OF MEMORANDUM OF UNDERSTANDING BETWEEN
THE BOARD OF FRANKLIN COUNTY COMMISSIONERS AND COLUMBUS PUBLIC HEALTH

This Agreement Modification is entered into on this _____ day of _____, 2021 (*date to be entered by the Franklin County Clerk*) by and between Columbus Public Health (“Provider”) and the Board of Commissioners, Franklin County, Ohio (“County”), on behalf of the Franklin County Office of Justice Policy and Programs for the continued provision of services and support related to the Rapid Resource Center located at the Franklin County Correction Center II, 2460 Jackson Pike, Columbus, OH. This is a modification of the Memorandum of Understanding originally approved on February 16, 2021 by Resolution Number 0121-21.

For the mutual considerations herein specified, the terms, including, but not limited to, the agreement as outlined in the original Memorandum of Understanding, are still legally binding upon the parties and shall remain as the governing documents.

The County and the Provider have agreed and do hereby agree the following sections from the original Contract will be amended and replaced with the following:

Section 2 Relationships, Roles and Responsibilities of the Parties

- 1) Funding allocated to support the reimbursement of Columbus Public Health for the processing and issuance of birth certificates requested by justice involved individuals receiving services through the Rapid Resource Center shall be increased by \$10,000 to a revised total amount of \$20,000. The unit cost of \$23.65 per birth certificate issued shall remain the same; and
- 2) The pool of individuals eligible to receive issuance of a birth certificate through this Agreement shall expand to include residents of the Franklin County Community Based Correctional Facility (CBCF) and Franklin County residents attending Community Pop Up events scheduled by the Central Ohio Restored Citizens’ Collaboration (CORCC); and
- 3) Funding to reimburse Columbus Public Health for issuance of birth certificates shall be expanded to include support from the FY2018 Comprehensive Opioid Abuse Site Based grant (CFDA #16.838 and #16.754), the FY2020 Comprehensive Opioid, Stimulant and Substance Abuse Site-based Program (CFDA #16.838) and the FY2018 and 2019 Edward Byrne Memorial Justice Assistance Grant programs. (CFDA #16.738).

Section 3 Terms of Contract


The term of the Agreement shall remain in effect through February 16, 2023.
