Situated in the State of Ohio, County of Franklin, City of Columbus, located in Farm Lot 17 of Flavel Tuller's Survey of Section 1, Township 2 North, Range 19 West, United States Military Lands, as recorded in Plat Book 3, Page 60, and being a part of Lot 66 of the Foxboro Village Section 2 Subdivision as recorded in Plat Book 51, Page 106, as conveyed to Daniel S. Custer by deed of record in Instrument Number 200204220101013, all records of the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows:

Being a parcel of land located on the right side of the Plat of the Centerline of Right-of-Way of FRA-C.R. 61-1.10, as recorded in Plat Book____, Page____;

Beginning at a 1" iron pipe marking the northeast corner of said Lot 66, being 40.00 feet right of Hard Road centerline station 138+22.34;

Thence South 02 degrees 20 minutes 55 seconds West, a distance of 5.00 feet along the easterly line of said Lot 66, being 45.00 feet right of station 138+22.34;

Thence North 87 degrees 39 minutes 05 seconds West, a distance of 31.20 feet across said Lot 66 to a point in the westerly line of said Lot 66, being 45.00 feet right of station 137+91.15;

Thence North 34 degrees 56 minutes 01 seconds East, a distance of 5.93 feet along the westerly line of said Lot 66 to the northwest corner of said Lot 66, being 40.00 feet right of station 137+94.34;

Thence South 87 degrees 39 minutes 05 seconds East, a distance of 28.00 feet along the northerly line of said Lot 66, and along the existing southerly right-of-way line of Hard Road, to the **Point of Beginning**, containing 0.003 acres, more or less;

The bearing datum of the afore-described parcel is based upon the Ohio State Plane Coordinate System, South Zone, NAD 1983 (1986 Adjustment), as measured using G.P.S. methods through the Franklin County Engineer's stations FRANK 74, FRANK 174, FCGS 7772, FCGS 6651, FCGS 2232, and FRANK 2218 RESET.
