[Surveyor's description of the premises follows]

Situate in the State of Ohio, County of Franklin, City of Columbus, being located in Half Section 51 in original Truro Township, Township 12, Range 21 of the Refugee Lands. The herein described parcel lies on the left side of the existing centerline of right-of-way of Refugee Road. All bearings and distances, stations and offsets are based on the Right-of-Way plans prepared by Burgess & Niple for the City of Columbus as shown on the centerline plat for Refugee Road as recorded in Plat Book 125, pages 58 – 61 of the Franklin County Recorder's Office and as on file with the City of Columbus in plan 3419-E. Being part of lands conveyed to the "REFUGEE ROAD PARTNERS III, CORP." (hereafter referred to as Grantor) as described in Instrument No. 201803080031559 of the Franklin County Recorder's Office and being more particularly described as follows:

COMMENCING at 75.00 feet left of the existing centerline of right-of-way of Refugee Road at station 83+60.81 and the **TRUE POINT OF BEGINNING** of the herein described parcel;

THENCE North 86 deg. 38 min. 25 sec. East for a distance of **39.66 feet** to 80.29 feet left of the existing centerline of right-of-way of Refugee Road at station 84+00.11;

THENCE South 81 deg. 18 min. 52 sec. East for a distance of **9.02 feet** to 79.61 feet left of the existing centerline of right-of-way of Refugee Road at station 84+09.10;

THENCE on a tangent curve to the left, with an **ARC LENGTH** of **13.86 feet**, a **RADIUS** of **20.00 feet**, a **TANGENT LENGTH** of **7.22 feet**, a **DELTA ANGLE** of **39 deg. 41 min. 49 sec.**, with a **CHORD BEARING** of **South 65 deg. 50 min. 05 sec. East** and a **CHORD DISTANCE** of **13.58 feet** to 75.00 feet left of the existing centerline of right-of-way of Refugee Road at station 84+21.88;

THENCE North 85 deg. 40 min. 59 sec. West for a distance of **61.07 feet BACK TO THE TRUE POINT OF BEGINNING.**

The above-described parcel contains 0.004 acres total, including 0.000 acres in the present road occupied (PRO), lying in Franklin County Auditors parcel number 010-270941.

The basis of bearings for the above-described parcel are based on the Grid North and the Ohio State Plane Coordinate System, South Zone, NAD83(2011), as established from a GPS survey utilizing the Ohio Department of Transportation's Virtual Reference System (VRS), performed by OHM-Advisors in November, 2015 and as expressed on said Right-of-Way plans and Centerline Plat prepared by Burgess & Niple for the City of Columbus on the existing centerline of Refugee Road by a monument box, located at the center of the box lid, at station 10+00.00 and a 1" rebar set in pavement at the centerline intersections of Refugee Road and Schwartz Road at station 28+89.33 with a bearing of South 85 deg. 43 min. 08 sec. East.

This description was prepared by Burgess & Niple, under the direct supervision of Michael D. Jones, P.S., Ohio License No. 8459 and is based on a recent survey of the existing boundary monument locations performed by OHM Advisors, under the direction of John Raab, Professional Surveyor, Ohio License Number 7863, under a sub-consultant agreement between Burgess & Niple and OHM Advisors, for said services.
