[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Township 4, Township 2, Range 17 of the United States Military Lands and being 0.069 acres within a 0.767 acre parcel conveyed to BLENDON PARK CONDOMINIUM ELEVENTH AMENDMENT-PART2, as described in Instrument Number 199806010131590 and being more particularly described as follows:

Being a parcel of land lying on the left side of the centerline of a survey made for project Hamilton Road, made by the Department of Transportation, and being located within the following described points in the boundary thereof:

Beginning on the westerly existing right-of-way of Hamilton Road, said point being 60.00 feet left of centerline Station 102+83.15;

Thence along the existing southerly property line of said 0.767 acre tract, North 85°48'39" West, a distance of 23.00 feet to a point on the existing southerly property line, being 83.00 feet left of centerline Station 102+83.50;

Thence across the said 0.767 acre tract, North 3°19'21" East a distance of 31.50 feet to a point being 83.00 feet left of centerline Station 103+15.00;

Thence across the said 0.767 acre tract, South 86°40'39" East a distance of 7.00 feet to a point being 76.00 feet left of centerline Station 103+15.00;

Thence across the said 0.767 acre tract, North 3°19'21" East a distance of 135.59 feet to a point being 76.00 feet left of centerline Station 104+50.59;

Thence across the said 0.767 acre tract, North 85°49'30" West a distance of 9.00 feet to a point being 85.00 feet left of centerline Station 104+50.73;

Thence across the said 0.767 acre tract, North 3°19'21" East a distance of 5.00 feet to a point on the northerly property line of said 0.588 acre tract, being 85.00 feet left of centerline Station 104+55.73;

Thence along the northerly property line of said 0.767 acre tract, South 85°49'30" East a distance of 25.00 feet to a point on the westerly right-of-way line of Hamilton Road, being 60.00 feet left of centerline Station 104+55.35;

Thence along the existing westerly right-of-way line of Hamilton Road, South 3°19'21" West a distance of 172.20 feet to the point of beginning, containing 0.069 acres, more or less.

The above described area is within Auditors Permanent Parcel Numbers 010-243777 thru 010-243781.

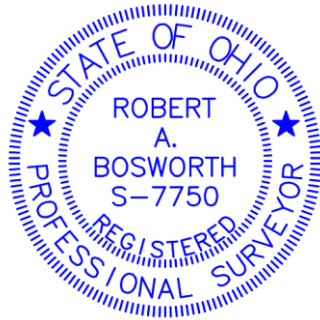
