Situate in the State of Ohio, County of Franklin, City of Columbus in the Quarter Township 2 of Township 1, Range 18, United States Military Lands, and being part of Lot 6 of Walhalla Terrace Subdivision as recorded in Plat Book 10, Page 88 of the Franklin County Recorder's Office, also known as being part of the property conveyed to Robert Bamattre and Cynthia Bamattree as Trustees of The Bamattre Family Trust dated June 11, 1990 and amended and restated June 5th, 2009 by Instrument Number 201505110060930 of the Franklin County Recorder's Office, (Franklin County Auditor's Parcel Numbers 010-052130-00), being Parcel 19-WD on the left side of the existing centerline of Right-of-Way of Indianola Avenue (Right-of-Way 60') as shown on the City of Columbus Right-of-Way Plans for Indianola Avenue (1908-A) and being more particularly described as follows:

Beginning for Reference at a Monument Box Set in the centerline of Right-of-Way of Indianola Avenue at Station 156+00.96. Thence, along said centerline of Right-of-Way of Indianola Avenue, South 03 degrees 52 minutes 37 seconds West, 674.11 feet to a point in said centerline of Right-of-Way of Indianola Avenue, said point being Station 149+26.85. Thence, leaving said centerline, North 86 degrees 07 minutes 23 seconds West, 30.00 feet to the northeast corner of said Lot 6, said point being at the intersection of the existing westerly Right-of-Way line of Indianola Avenue and the existing southerly Right-of-Way line of an alley (Right-of-Way 16'), said point also being 30.00 feet left of Station 149+26.85 of said centerline of Right-of-Way of Indianola Avenue and the **True Point of Beginning** for the parcel herein described;

Thence, along the easterly line of said Lot 6, the same being said existing westerly Right-of-Way line of Indianola Avenue, **South 03 degrees 52 minutes 37 seconds West, 41.91 feet** to the southeast corner of said Lot 6, the same being the northeast corner of Lot 5 of said Walhalla

Terrace Subdivision, said point being 30.00 feet left of Station 148+84.94 of said centerline of Right-of-Way of Indianola Avenue;

Thence, along the common line of said Lots 5 and 6, **North 86 degrees 07 minutes 23 seconds West, 1.00 foot** to an Iron Pin Set in said common line, said point being 31.00 feet left of Station 148+84.94 of said centerline of Right-of-Way of Indianola Avenue;

Thence, crossing said Lot 6, **North 03 degrees 52 minutes 37 seconds East, 41.91 feet** to a Mag Spike Set in the northerly line of said Lot 6, the same being the existing southerly Right-of-Way line of said alley, said point being 31.00 feet left of Station 149+26.85 of said centerline of Right-Of-Way of Indianola Avenue;

Thence, along the southerly Right-of-Way line of said alley, the same being the northerly line of said Lot 6, **South 86 degrees 07 minutes 23 seconds East, 1.00 foot** to the **Point of Beginning**, containing 0.001 acre (41.9 sq. ft), more or less, all of which is in Franklin County Auditor's Parcel Numbers 010-052130-00.

Subject to all, legal, easements, rights-of-way, conditions and restrictions.
