Situate in the State of Ohio, County of Franklin, City of Columbus, located in Fractional Section 4, Township 5, Range 22, Refugee Lands, being part of Lot 81 of Terrace View Addition of record in Plat Book 4, Page 250, as conveyed to Brooke Zamudio and James White by deed of record in Instrument Number 201308090136843, records of the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows;

Being a parcel of land lying on the right side of the Centerline of Right-of-Way as delineated upon the E. Second Avenue Right-of-Way Plan on file with the City of Columbus (3407-E);

**Beginning** at an iron pin set in the common line of Lots 82 and 81 of Terrace View Addition of record in Plat Book 4, Page 250, and in the new southerly right of way line of Second Avenue (Parcel 25-WD), being 29.00 feet right of Centerline Right-of-Way station 28+44.71;

Thence South 86 deg. 33 min. 10 sec. East, a distance of 30.00 feet along said new southerly right of way line to an iron pin set in the common line of Lots 81 and 80 of said Terrace View Addition, being 29.00 feet right of Centerline Right-of-Way station 28+74.71;

Thence South 03 deg. 44 min. 12 sec. West, a distance of 6.00 feet along the common line of said Lots 81 and 80 to a point being 35.00 feet right of Centerline Right-of-Way station 28+74.68;

Thence North 86 deg. 33 min. 10 sec. West, a distance of 30.00 feet across said Lot 81 to a point in the common line of said Lots 82 and 81, being 35.00 feet right of Centerline Right-of-Way station 28+44.68;

Thence North 03 deg. 44 min. 12 sec. East, a distance of 6.00 feet along said common line of Lots 82 and 81 to the **Point of Beginning** of the herein described parcel, containing 180 square feet, more or less, of which 0.000 square feet lies within the existing Present Road Occupied.

Of the above described area, 180 square feet are contained within Franklin County Auditor's Parcel 010-016081.

Bearings are based on the Ohio State Plane Coordinate System, South Zone, NAD 83 (NSRS 2007), as established from a GPS survey in October 2017, and are based on the bearing of South 86 deg. 41 min. 21 sec. East for the centerline of E. Second Avenue, as determined by occupying Franklin County Geodetic Control Monuments "COC17-82" and "TACKETT".

This description was prepared by Steven E. Rader, registered surveyor 7191, and is based upon a field survey for the City of Columbus in 2017, by Stantec Consulting Services, Inc., under the direction of said surveyor.
