Grantor/Owner, for himself and his heirs, executors, administrators, successors and assigns, reserves all existing rights of ingress and egress to and from any residual area (as used herein, the expression "Grantor/Owner" includes the plural, and words in the masculine include the feminine or neuter).

[Surveyor's description of the premises follows]

Situate in the State of Ohio, County of Franklin, City of Columbus, being located in Half Section 52 in original Truro Township, Township 12, Range 21 of the Refugee Lands. The herein described parcel lies on the left side of the existing centerline of Right-of-way of Refugee Road. All bearings and distances, stations and offsets are based on the Right-of-Way plans prepared by Burgess & Niple for the City of Columbus as shown on the centerline plat for Refugee Road as recorded in Plat Book 125, pages 58 – 61 of the Franklin County Recorder's Office and as on file with the City of Columbus in plan 3419-E. Being part of lands conveyed to the "THOMAS A. MCDOWELL AND ALLEN E. MCDOWELL, DIANE A. MCDOWELL UNDER AGREEMENT FBO DIANE A. MCDOWELL DATED 1-2-1966, EQUALLY" (hereafter referred to as Grantor) as described in Deed Book 3559, page 28 of the Franklin County Recorder's Office and being more particularly described as follows:

COMMENCING at a **1" Rebar Set** at the intersection of the existing centerlines of right-of-way of Refugee Road (width varies) and Weyburn Road (60 foot right-of-way) on the existing centerline of right-of-way of Refugee Road at station 44+07.11, also on the existing centerline of right-of-way of Weyburn Road at station 50+00.00;

THENCE with the existing centerline of right-of-way of Refugee Road, **South 85 deg. 36 min. 08 sec. East** for a distance of **179.68 feet** to the Southeast corner of a 1.1288 acre tract as conveyed to the City of Columbus in Deed Book 2842, page 126 and the Southwest corner of a 1.7906 acre tract designated as Parcel No. 15 as conveyed to the City of Columbus in Deed Book 2837, page 384 in on the existing centerline of right-of-way of Refugee Road at station 45+87.11;

THENCE with the common line of said 1.1288 acre tract and Parcel No. 15, **North 04 deg. 05 min. 57 sec. East** for a distance of **60.00 feet** to Northeast corner of said 1.1288 acre tract, the Northwest corner of said Parcel No. 15, and the Southeast corner as dedicated in the northerly right-of-way line of Refugee Road and the Grantor's Southwest corner at 60.00 feet left of the existing centerline of right-of-way of Refugee Road station 45+86.79 and the **TRUE POINT OF BEGINNING** of the herein described parcel;

THENCE with the Grantor's West line and the northerly right-of-way line of Refugee Road as dedicated in Plat Book 45, page 118, **North 04 deg. 05 min. 57 sec. East** for a distance of **2.04 feet** to an **Iron Pin Set** at 62.04 feet left of the existing centerline of right-of-way of Refugee Road at station 45+86.78;

THENCE through the Grantor's lands the following two (2) courses:

- 1) **South 86 deg. 46 min. 57 sec. East** for a distance of **263.31 feet** to an **Iron Pin Set** at 67.47 feet left of the existing centerline of right-of-way of Refugee Road at station 48+50.04;
- 2) **South 84 deg. 02 min. 52 sec. East** for a distance of **275.29 feet** to an **Iron Pin Set** in the north line of said Parcel No. 15 on the North right-of-way line of Refugee Road at 60.00 feet left of the existing centerline of right-of-way of Refugee Road at station 51+25.23;

THENCE with the North line of said Parcel No. 15 on the North right-of-way line of Refugee Road, **North 85 deg. 36 min. 08 sec. West** for a distance of 538.43 feet **BACK TO THE TRUE POINT OF BEGINNING**.

The above-described parcel contains 0.052 acres total, including 0.000 acres in the present road occupied (PRO), lying in Franklin County Auditors parcel number 010-016465.

The basis of bearings for the above-described parcel are based on the Grid North and the Ohio State Plane Coordinate System, South Zone, NAD83(2011), as established from a GPS survey utilizing the Ohio Department of Transportation's Virtual Reference System (VRS), performed by OHM-Advisors in November, 2015 and as expressed on said Right-of-Way plans and Centerline Plat prepared by Burgess & Niple for the City of Columbus on the existing centerline of Refugee Road by a monument box, located at the center of the box lid, at station 10+00.00 and a 1" rebar set in pavement at the centerline intersections of Refugee Road and Schwartz Road at station 28+89.33 with a bearing of South 85 deg. 43 min. 08 sec. East.

All Iron Pins described as set are 5/8" x 30" rebar with a with a yellow plastic cap stamped "R/W Burgess & Niple" and shall be placed upon notification from the City of Columbus at the completion of construction.

This description was prepared by Burgess & Niple, under the direct supervision of Michael D. Jones, P.S., Ohio License No. 8459 and is based on a recent survey of the existing boundary monument locations performed by OHM Advisors, under the direction of John Raab, Professional Surveyor, Ohio License Number 7863, under a sub-consultant agreement between Burgess & Niple and OHM Advisors, for said services.
